Abstract: Recent trends in linguistics require interdisciplinary approaches to the analysis of linguistic features. The reason is that in anthropocentric paradigm, which is dominant now, puts human in tho the centre of the linguistic studies. For this reason, current cognitive, pragmatic and linguapragmatic analysis consider human factor in linguistic analysis to understand how language is formed and how it is expressed. In this article, from this point of view, economic terms will be analyzed and their cognitive features are discussed to prove their linguapragmatic features. The analysis will develop the explanation behind the terms and how they emerge as a human creation product. The article will uses conceptual and cognitive analysis methods to illustrate them. For this reason, in the new paradigm it has been common to encounter interdisciplinary features of scientific language.

In modern linguistics it has become popular to see metaphors in not only economic lessons, but also in reports. The reason is that the late progress in linguistics has made it possible to view metaphor from a cognitive approach, as a device to explain abstract notions clearly. Conceptual metaphor is not considered as a linguistic ornament, but a device to deal with human cognition and knowledge structures. According to G. Lakoff and M. Johnson, the importance of metaphor is to use one thing to understand and experience another one. Conceptual metaphor contains two domains: target domain and source domain. Analyzing through mapping from source

domain to target can enable us to understand better the notions of economics. G.Lakoff and M. Johnson contend that metaphor is a feature of ideas that serves as a means of assisting us in comprehending ideas that we are unfamiliar with. According to Valenzuela and conceptual metaphor is a cognitive phenomenon rather than a linguistic one. It is among the five conceptual structure types that rely on the fields process of mapping two knowledge.Furthermore, Valenzuela and Lakoff and Johnson contend that our conceptual framework is metaphorical. Everything around us is metaphoric because our conceptual system is metaphoric. Furthermore, a human's conceptual framework is ubiquitous; it may be felt and found everywhere, according to Hamawand. Lakoff and Johnson contend that metaphor is not a linguistic issue and that our conceptual system and thoughts are metaphorical in nature. It is possible to argue that our language serves as a means of communicating our metaphorical ideas. To put it another way, we use metaphoric phrases to convey our metaphoric ideas.

Nowadays due to the freedom of economic media some scholars believe that economic discourse has started applying figurative language to some extent, especially metaphors and metaphorical phraseological units.

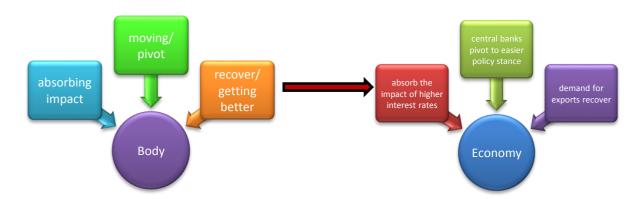
"As the global economy absorbs the impact of higher

interest rates and central banks pivot to an easier policy stance, demand for Canada's exports is expected to recover in the second half of the year after a soft start".

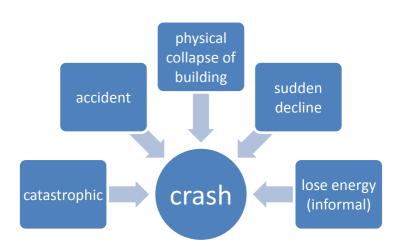

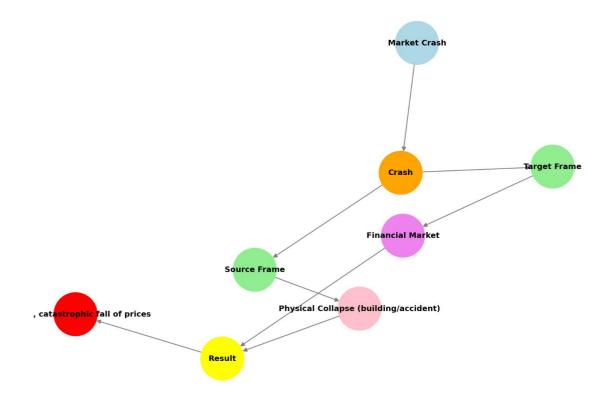

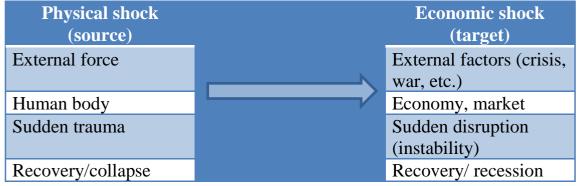
The following diagram will connect lines that overlap similar meanings related to "market" and the features of "crash". As Uzbek linguist D.Ashurova mentioned,
